Incentive-based Program Tracking, Performance, May Be Key to Support Training of Some Professionals in U.S.

Workforce shortages of <u>primary care physicians</u> and highly qualified <u>special education teachers</u>, for example, pose a mounting public policy challenge. To address these systemic national shortages, policy makers are turning to a family of incentive-based programs, including service obligation scholarships, loan repayment programs, and loan forgiveness programs.

The concept of these incentive programs is simple enough: reduce or remove a student's financial burden by providing an educational scholarship with a post-graduation service requirement or providing a graduate with loan payment assistance/cancelation for maintaining employment in a needed area. Seemingly straightforward, the tracking of data can be challenging for the federal and state agencies sponsoring programs and for the students and employers involved.

Optimal Research Presentations at National Conferences

Poster Presentation on Quality Indicators at Fall 2009 APHA Annual Meeting

Optimal researchers Olajumoke "Jumy" Adekeye and Danielle Ward have had their work on health quality indicators accepted as a poster presentation at the 137th American Public Health Association (APHA) Annual Meeting, November 7-11, 2009, in Philadelphia. Their work, titled "Incorporating quality indicators in electronic health record development," evaluated the technical feasibility of using electronic systems already in place in hospitals nationwide to collect data for performance measurements. In addition, they identified the potential ramifications that the use of these interim systems may have on improving the healthcare of Medicare patients.

Poster Presentation on Evaluation of Virginia's Children's Mental Health Program at Fall 2009 APHA Annual Meeting

Optimal researchers Grace Hong, Katlo Manthe, and Kelly Gent have had their work on Virginia's Children's Mental Health (CMH) Program accepted as a poster presentation at the 137th American Public Health Association Annual Meeting, November 7-11, 2009, in Philadelphia. The evaluation of the CMH Program assesses how children who transition out of residential care and receive community-based services through the CMH Program experience changes in their functional levels over time as compared with similar children who remain in residential care. The comparison group will be identified by matching baseline characteristics, such as diagnosis and baseline functional level. Their work, titled "Evaluation of a Virginia Medicaid Waiver Program: Assessing the effectiveness and implementation fidelity of the Children's Mental Health Program," also monitors the fidelity of the CMH program by comparing the adherence of the actual program implementation to the intended program theory and design.

Optimal Fellow Leads Session, Research Associate Contributes Presentation, at 2009 AERA Annual Meeting

Toks Fashola, PhD, Senior Research Fellow with Optimal, served as panel chair for a session at the American Education Research Association (AERA) conference in San Diego, April 13-17. The title of the panel was "Sample Recruitment, Design Implementation, and Data Collection in RFT Designs: Districts and Schools as Partners." Monica Leal Priddy, a Research Associate at Optimal, presented her research in the session. Her presentation, titled "Recruitment Challenges, Considerations, and Best Practices for Recruitment Efforts," described lessons learned in the context of two Optimal projects: the National Charter School Evaluation project, on which Optimal serves as a subcontractor to Mathematica Policy Research, and the Study of Teacher Preparation in Early Reading Instruction, on which Optimal serves as the prime contractor. Going Green

Portion of 2009 Stimulus Act Aims to Promote Energy Efficiency

The American Recovery and Reinvestment Act of 2009 dedicated a total of \$61.3 billion out of the \$787 billion to the energy sector. The roughly 8% of the stimulus package for energy sectors target numerous green initiatives that implement environmental policy and technology, notably:

- \$500 million for training of "green-collar workers" (i.e., environmental design, policy, and technology);
- \$250 million to increase energy efficiency in low-income housing; and
- \$300 million to buy energy-efficient appliances.

For consumers, the new legislation has increased the

energy efficient tax credit to as much as 30% (Energy Star Tax Credits).
